**RESOLUTION AWARDING AN OPEN-ENDED CONTRACT FOR  
PROVIDING DEER CARCASS REMOVAL SERVICES FOR THE

WHEREAS this Board duly received and opened bids for an open-ended contract for providing deer carcass removal services for the County of Cumberland and the Cumberland County Cooperative Contract Purchasing System Identifier # 181-CCCCPS; and

WHEREAS, bids were received as follows:

WHEREAS, the Director of Purchasing has reported that Deer Carcass Removal Services, LLC was the lowest responsive, responsible bidder;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That an open-ended contract for providing deer carcass removal services for the County of Cumberland and the Cumberland County Cooperative Contract Purchasing System Identifier # 181-CCCCPS is hereby awarded to Deer Carcass Removal Services, LLC, PO Box 328, Cream Ridge, NJ 08514 in accordance with the specifications and the bid of the contractor for the contract period November 1, 2010, through October 31, 2011. Continuation of this contract in 2011 shall be contingent upon appropriation of sufficient funds by the Board of

Chosen Freeholders in the temporary and/or permanent 2011 budget. The County shall have the option to renew this contract for two (2) additional one (1) year terms.

2. That the proper officers of this Board be and the same are hereby authorized and directed to execute the contract hereby awarded.

3. The proper account numbers will be charged and funds encumbered prior to services being provided.
