**RESOLUTION AWARDING AN OPEN-ENDED CONTRACT FOR
SUPPLYING AND DELIVERING #2 FUEL OIL FOR COUNTY OF
CUMBERLAND AND FOR PARTICIPATING MEMBERS OF THE
CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM
NUMBER 64-CCCPS; BID # 10-58 (RIGGINS, INC.)**

WHEREAS this Board duly received and opened bids for an open-ended contract for supplying and delivering #2 fuel oil for the County of Cumberland and for participating members of the Cumberland County Cooperative Pricing System Number 64-CCCPS; and

WHEREAS, bids were received as follows:

Major Petroleum Industries, Rosenhayn, NJ	\$.2355 delivery/\$37,800.00 est. (County) \$.2355 delivery/\$50,652.00 (Cooperative)

WHEREAS, the Director of Purchasing has reported that Riggins Inc. was the lowest responsive, responsible bidder;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That an open-ended contract for supplying and delivering #2 fuel oil for the County of Cumberland and for participating members of the Cumberland County Cooperative Pricing System Number 64-CCCPS is hereby awarded to Riggins, Inc., P.O. Box 150, Millville, NJ 08332 in accordance with the specifications and the bid of the contractor in the estimated amount of \$37,402.50 for the contract period December 1, 2010 through November 30, 2012.

2. That the proper officers of this Board be and the same are hereby authorized and directed to execute the contract hereby awarded.

3. That the proper account numbers will be charged and funds encumbered prior to services being provided.
