WHEREAS, the Director of Purchasing has reported that South State, Inc., PO Box 68, Bridgeton, New Jersey 08302 was the lowest responsive, responsible bidder;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby recommends an open-ended contract be awarded to South State, Inc. in accordance with the specifications and the bid of the contractor for the Cumberland County Public Works Department and the Cumberland County Cooperative Contract Purchasing System Identifier # 181-CCCCPS for the contract period May 1, 2010, through April 30, 2011.
2. That the proper officers of this Board are hereby authorized and directed to

execute the contract hereby awarded.

3. That the proper account numbers will be charged and funds encumbered prior to services being provided and this contract shall be contingent upon appropriation of sufficient funds in the temporary and/or permanent 2010 and 2011 Budgets.
