**RESOLUTION AWARDING AN OPEN-ENDED CONTRACT FOR BID #
10-23; PROVIDING TRASH/RUBBISH REMOVAL FOR CUMBERLAND
COUNTY AND PARTICIPATING MEMBERS OF THE CUMBERLAND
COUNTY COOPERATIVE PRICING SYSTEM NUMBER 64-CCCPS
(WASTE MANAGEMENT OF NEW JERSEY, INC.)**

WHEREAS this Board duly received and opened bids for an open-ended contract for providing trash/rubbish removal for Cumberland County and participating members of the Cumberland County Cooperative Pricing System Number 64-CCCP; and

WHEREAS, bids were received as follows:

EarthTech; Greenfield, NJ	\$71,462.40*
Waste Management; Ewing, NJ	\$74,109.50
Giordano; Vineland, NJ	\$87,007.28
C&H Disposal; Elmer, NJ	\$88,194.00

* Reject bid for failure to provide a completed collection schedule for County locations.

WHEREAS, the Director of Purchasing has reported that Waste Management of New Jersey, Inc. was the lowest responsive, responsible bidder;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That an open-ended contract for providing trash/rubbish removal for Cumberland County and participating members of the Cumberland County Cooperative Pricing System Number 64-CCCPS is hereby awarded to Waste Management of New Jersey, Inc., 107 Silvia Street, Ewing, NJ 08628 in accordance with the specifications and the bid of the contractor in the amount of \$

74,109.50 for contract period October 1, 2010, through September 30, 2012. This contract shall be contingent upon appropriation of sufficient funds by the Board of Chosen Freeholders in the temporary and/or permanent 2011 and 2012 budgets. Resolution shall additionally declare Waste Management of New Jersey, Inc. as winning bidder for Lawrence Township (\$1,764.88), Commercial Township Schools (\$10,589.28), Greenwich Township School (\$2,296.32), Stow Creek School (\$2,296.32) and Upper Deerfield Schools (\$20,108.40) and Giordano as winning bidder for the Cumberland County Technical Education Center (\$13,665.60).

2. That the proper officers of this Board be and the same are hereby authorized and directed to execute the contract hereby awarded.

3. That the proper account numbers will be charged and funds encumbered prior to services being provided.
