WHEREAS, the Director of Purchasing has reported that Oceanport, LLC, PO Box 608, Claymont, DE 19703 was the lowest responsive, responsible bidder;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby recommends an open-ended contract be awarded to Oceanport, LLC for providing and delivering rock salt for the County of Cumberland and the Cumberland County Cooperative Contract Purchasing System Identifier # 181-CCCCPS in accordance with the specifications and the bid of the contractor for the contract period August 1, 2010 through July 31, 2011 and shall be contingent upon appropriation of sufficient funds by the

Board of Chosen Freeholders in the temporary and/or permanent 2011 budget.

2. That the proper officers of this Board are hereby authorized and directed to execute the contract hereby awarded.

3. That the proper account numbers will be charged and funds encumbered prior to services being provided.
