Re: Cooperative Contract for Providing and Delivering Ice Control Sand

On June 23, 2010, the County of Cumberland, solicited bids for Providing and Delivering Ice Control Sand for itself and for the Cumberland County Cooperative Contract Purchasing System, Identifier Number 181-CCCCPS, as authorized by N.J.S.A. 40 A:11-11(6) and regulated by N.J.A.C. 5:34-7.1.

This legislation permits government entities within the geographic boundaries of Cumberland County to utilize any contract made by the County provided that the successful bidder to the County is awarded a contract and has elected to extend their prices, and the terms and conditions of the County contract, to those government entities.

On July 22, 2010, the Cumberland County Board of Chosen Freeholders adopted a resolution (copy attached) to award an open-ended contract to Whibco of New Jersey, Incorporated, 87 East Commerce Street, Bridgeton, New Jersey, 08302, to provide those services to the County. Additionally, Whibco elected to extend their prices to government entities within the geographic boundaries of the County; the Board declared them winning bidder for those government entities.

You may therefore, on a strictly voluntary basis, enter into a contract with Whibco for Providing and Delivering Ice Control Sand. All terms and conditions of the contract

awarded by the County, including all prices, would apply to any contract made with Whibco. The prices are fixed for the term of the contract.

The contract starts August 1, 2010, and terminates July 31, 2011.

The price per ton is \$10.75.

Delivery is to be made within five (5) business days after placement of the order.
