WHEREAS, this Board duly received and opened bids for Providing and Delivering Ice Control Sand for the County of Cumberland and the Cumberland County Cooperative Contract Purchasing System Identifier # 181-CCCCPS; and

WHEREAS, the Director of Purchasing has reported that Whibco of New Jersey, Inc., 87 East Commerce Street, Bridgeton, NJ 08302 was the lowest responsive, responsible bidder;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby recommends an open-ended contract be awarded to Whibco of New Jersey, Inc. for providing and delivering ice control sand for the County of Cumberland and the Cumberland County Cooperative Contract Purchasing System Identifier # 181-CCCCPS in accordance with the specifications and the bid of the contractor for the contract period August 1, 2010, through July 31, 2011 and contingent upon appropriation of sufficient funds by the Board of Chosen Freeholders in the temporary and/or permanent 2011 budget.

2. That the proper officers of this Board are hereby authorized and directed to execute the contract hereby awarded.

3. That the proper account numbers will be charged and funds encumbered prior to services being provided.
