**RESOLUTION AWARDING AN OPEN-ENDED CONTRACT FOR
SUPPLYING AND DELIVERING BREAD AND BAKERY PRODUCTS
TO CUMBERLAND COUNTY AND TO PARTICIPATING MEMBERS
OF THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM
NUMBER 64-CCCPS; BID #10-29 (PECHTERS OF SOUTHERN NEW
JERSEY)**

WHEREAS this Board duly received and opened bids for an open-ended contract for supplying and delivering bread and bakery products to Cumberland County and to participating members of the Cumberland County Cooperative Pricing System Number 64-CCCPS; and

WHEREAS, bids were received as follows:

Deluxe Italian Bakery, Runnemede, NJ	\$34,305.14

WHEREAS, the Director of Purchasing has reported that Pechters of Southern New Jersey was the lowest responsive, responsible bidder;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That an open-ended contract for supplying and delivering bread and bakery products to Cumberland County and to participating members of the Cumberland County Cooperative Pricing System Number 64-CCCPS is hereby awarded to Pechters of Southern New Jersey, PO Box 2069, 2 Surrey Lane, Cinnaminson, NJ 08077 in accordance with the specifications and the bid of the contractor in the estimated amount of \$24,240.97 for the contract period September 1, 2010 through August 31, 2011.

2. That the proper officers of this Board be and the same are hereby authorized and directed to execute the contract hereby awarded.

3. That the proper account numbers will be charged and encumbered prior to services being provided.
