**RESOLUTION AWARDING AN OPEN-ENDED CONTRACT FOR
SUPPLYING AND DELIVERING MILK AND DAIRY PRODUCTS TO
CUMBERLAND COUNTY AND TO PARTICIPATING MEMBERS OF
THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM
NUMBER 64-CCCPS, BID #10-30 (HY-POINT DAIRY FARMS INC.)**

WHEREAS this Board duly received and opened bids for an open-ended contract for supplying and delivering milk and dairy products to Cumberland County and to participating members of the Cumberland County Cooperative Pricing System Number 64-CCCPS; and

WHEREAS, bids were received as follows:

Hy-Point Dairy Farms Inc., Wilmington, DE	\$79,598.47
Cream-O-Land Dairy, Florence, NJ	\$82,726.83

WHEREAS, the Director of Purchasing has reported that Hy-Point Dairy Farms Inc. was the lowest responsive, responsible bidder;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That an open-ended contract for supplying and delivering milk and dairy products to Cumberland County and to participating members of the Cumberland County Cooperative Pricing System Number 64-CCCPS is hereby awarded to Hy-Point Dairy Farms Inc., 425 Beaver Valley Rd., Wilmington, DE 19803 in accordance with the specifications and the bid of the contractor in the estimated amount of \$79,598.47 for the contract period September 1, 2010, through August 31, 2011.

2. That the proper officers of this Board be and the same are hereby authorized and directed to execute the contract hereby awarded.

3. The proper account numbers will be charged and encumbered prior to services being provided.
