**RESOLUTION AWARDING AN OPEN-ENDED CONTRACT FOR  
PROVIDING AS-REQUIRED INSTALLATION AND REPAIR SERVICES  
FOR THE COUNTY OF CUMBERLAND AND THE CUMBERLAND  
COUNTY COOPERATIVE CONTRACT PURCHASING SYSTEM  
IDENTIFIER #181-CCCCPS; BID #10-35 (GEORGE SPARKS, INC.)**

WHEREAS this Board duly received and opened bids for an open-ended contract for providing as-required electrical installation and repair services for the County of Cumberland and the Cumberland County Cooperative Contract Purchasing System Identifier # 181-CCCCPS; and

WHEREAS, the Director of Purchasing has reported that George Sparks, Inc. was the lowest responsive, responsible bidder;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That an open-ended contract for providing as-required electrical installation and repair services for the County of Cumberland and the Cumberland County Cooperative Contract Purchasing System Identifier # 181-CCCCPS is hereby awarded to George Sparks, Inc. in accordance with the specifications and the bid of the contractor for the contract period July 1, 2010, through June 30, 2011. The County shall have the option to renew this contract for two (2)

additional one (1) year terms. This contract shall be contingent upon appropriation of sufficient funds by the Board of Chosen Freeholders in the temporary and/or permanent 2010 and 2011 budgets.

2. That the proper officers of this Board be and the same are hereby authorized and directed to execute the contract hereby awarded.

3. The proper account numbers will be charged and funds encumbered prior to services being provided.
