**RESOLUTION AWARDING AN OPEN-ENDED CONTRACT FOR
PROVIDING VEHICLE REPAIR SERVICES FOR THE COUNTY OF
CUMBERLAND AND THE CUMBERLAND COUNTY COOPERATIVE
CONTRACT PURCHASING SYSTEM IDENTIFIER #181-CCCCPS (BOB
NOVICK CHEVROLET, INC.; QUALITY LINCOLN MERCURY
HYUNDAI, INC.)**

WHEREAS this Board duly received and opened bids for an open-ended contract for providing vehicle repair services for the County of Cumberland and the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS; and

WHEREAS, bids were received as follows:

Bob Novick Chevrolet; Bridgeton, NJ	\$65.00/hr./30% mark-up
Quality Lincoln Mercury; Millville, NJ	\$72.00/hr./25% mark-up

WHEREAS, the Director of Purchasing has reported that Bob Novick Chevrolet, Inc. and Quality Lincoln Mercury Hyundai, Inc. were the lowest responsive, responsible bidders;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That an open-ended contract for providing vehicle repair services for all non-Ford Vehicles for the County of Cumberland and the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS is hereby awarded to Bob Novick Chevrolet, Inc., 808 North Pearl Street, Bridgeton, New Jersey 08302 in accordance with the specifications and the bid of the contractor for the contract period April 1, 2010 through March 31, 2011.

2. That an open-ended contract for providing vehicle repair services for all Ford

vehicles for the County of Cumberland and the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS is hereby awarded to Quality Lincoln Mercury Hyundai, Inc. in accordance with the specifications and the bid of the contractor for the contract period April 1, 2010 through March 31, 2011.

3. That the proper officers of this Board be and the same are hereby authorized and directed to execute the contracts hereby awarded.

4. That the proper account numbers will be charged and funds encumbered prior to services being provided. These contracts shall be contingent upon appropriation of sufficient funds in the temporary and/or permanent 2010 and 2011 Budgets. The County shall have the option to renew these contracts for two (2) additional one (1) year terms.
