**RESOLUTION AWARDING CONTRACT FOR SUPPLYING AND  
DELIVERING VOC-COMPLIANT HIGH PERFORMANCE COLD  
PATCH FOR THE CUMBERLAND COUNTY PUBLIC WORKS  
DEPARTMENT AND THE CUMBERLAND COUNTY COOPERATIVE  
CONTRACT PURCHASING SYSTEM IDENTIFIER # 181-CCCCPS; BID  
# 10-04 (RESUBMISSION) (SOUTH STATE, INC.)**

WHEREAS this Board duly received and opened bids for an open-ended contract for supplying and delivering VOC-compliant high performance cold patch for the Cumberland County Public Works Department and the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS; and

WHEREAS, bids were received as follows:

	County Pick-Up	Supply/Deliver
South State; Bridgeton, NJ	\$100.00/ton/600 tons*	\$105.00/ton
American Asphalt; W. Collingswood Heights, NJ	\$95.00/ton/600 tons*	\$101.00/ton

\* For bid evaluation purposes \$4.00/mile was added for total round-trip mileage for County pick-up of materials from the bidders plant location; South State (2 miles round-trip for County pick-up) plus supply/deliver equals \$123,400.00 total bid; American Asphalt (35.97 miles round-trip for County pick-up) plus supply/deliver equals \$124,794.00.

WHEREAS, the Director of Purchasing has reported that South State, Inc., P.O. Box 68, Bridgeton, New Jersey 08302 was the lowest responsive, responsible bidder;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That an open-ended contract for supplying and delivering VOC-compliant high

performance cold patch for the Cumberland County Public Works Department and the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS is hereby awarded to South State, Inc. in accordance with the specifications and the bid of the contractor for the contract period May 1, 2010 through April 30, 2011.

2. That the proper officers of this Board be and the same are hereby authorized and directed to execute the contract hereby awarded.

3. That the proper account numbers will be charged and funds encumbered prior to services being provided and this contract shall be contingent upon appropriation of sufficient funds in the temporary and/or permanent 2010 and 2011 Budgets.
