- ⇒ **Free state-wide health emergency notification system**
 - ⇒ **Available to all public safety professionals**
 - ⇒ **Provides accurate public health information**
 - ⇒ **Supports state and local health emergency preparedness and response efforts**
- ⇒ **Link together local, state, and federal partners to protect communities from natural and man-made disasters.**
 - ⇒ **Including emergency management, fire, law enforcement, and emergency medical technicians.**
 - ⇒ **Reliable sources from the NJ Department of Health and Senior Services, Centers for Disease Control and Prevention, local health departments, and more.**
 - ⇒ **Planning and assessment, disease surveillance and investigation, data collection and sharing, emergency communications, community education and outreach, and workforce training.**

Are You Part of the NJLINCS HAN?

Started in 1997 by the New Jersey Department of Health by the office of Local Health with the cooperation of NJ's local health departments, NJLINCS is an electronic information system that supports interactive reporting, data analysis, and the dissemination of public health information.

Throughout the state, there are 22 LINC agencies. All LINC agencies are currently developing a Community Health Alert and Information Network (CHAIN) which will connect public health departments to organizations within the community for electronic sharing and response to public health incidents. These LINC notifications are sent out with an alert and the urgency of the message.
